



## **2025 Sister Carol Crosson Endowment Foundation Grant Application**

**2025 Priorities: Travel for American Sokol participants 18 years of age or younger to ASO Chicago Slet; Chicago Instructors School; and, St. Louis National Camp.**

**2025 Total Budget available \$15,000**

This grant is made available through an Endowment set up on behalf of Sister Carol Crosson and administrated through the ASO Foundation and is meant for American Sokol traveling youth participants ONLY. This application is for those youth traveling by air or car to compete, drill, be schooled at the Chicago Prague Slet ONLY arriving June 25 through June 29, 2025; Chicago Instructors School (following the Slet and in Chicago); and National Camp (St. Louis) June 23-29, 2025.

### **Instructions**

**NOTE:** ALL lines/questions must be filled out. A narrative cover letter can be useful to describe participants' intentions. American Sokol Foundation does not guarantee the budget approval by the executive board of subsequent years. Approvals are done on an annual basis.

#### **Examples of Eligible Expenses for Sister Carol Crosson Endowment Foundation Grants:**

Grants from this fund are meant for American Sokol youth students (ONLY) up to and including the age of 18 years of age who are participating in competition or performing in a calisthenics routine on the field at the Chicago Slet in 2025 or Chicago Instructors School with a certificate of completion and/or participating in the St. Louis National Camp. (See Standard Operating Procedure II. B. 5. h. on ASO Travel.)

- Youth traveling expenses up to 50% **for airfare only OR** Youth traveling expenses up to 50% **for mileage (Government \$.70/mile) and tolls** to training/performance/tournament/competition directly from home base. Indicate all air flights, and costs. (Air Meal costs, transportation to airport and seat upgrades and baggage are not covered.) Evidence of when purchased, copies of ticket costs, tickets issued, etc. will be required for proof of use by the participant.
- Youth Participant registration expense copy showing participation **MUST** come with final report and **copy of final certificate of completion if appropriate and/or picture of participation.**

NOTE: This is a uniquely structured award. The award recommendations from the Foundation Committee and Sister Carol Crosson herself goes to the Executive Board in May for approval.

Please expect a return email indicating that the Foundation has received a copy of the application. The Foundation will notify the unit about the award in early June. The unit distributes the award to the participant. A check will be cut from the Edward Jones fund and sent directly to the unit after verification of the expenses/participation of all events (August 15, 2025). Receipts/Final report on the expenses are expected 30 days after the end of the program (dates cited). Should a participant not attend due to illness, poor behavior or the like, they will be automatically removed from the grant amount.
